

## **SUMMARY ANNUAL REPORT**

### **For Nektar Therapeutics Employees Benefit Plan**

This is a summary of the annual report of the Nektar Therapeutics Employees Benefit Plan, EIN 94-3134940, Plan No. 502, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Insurance Information**

The plan has contracts with National Union Fire Insurance Company Of Pittsburgh, Pa, Kaiser Foundation Health Plan, Inc., Blue Cross Of California, Delta Dental Of California, Vision Service Plan, Blue Cross And Blue Shield Of Alabama, Metlife Legal Plans, Curalinc Healthcare, Metropolitan General Insurance Company and Unum Life Insurance Company Of America to pay Medical, Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Business Travel Accident, and Legal claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$3,820,458.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2024, the premiums paid under such "experience-rated" contracts were \$1,410,364 and the total of all benefit claims paid under these contracts during the plan year was \$1,296,165.
